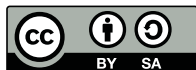

1 Overview

PBRUTTO covers all individuals, who were successfully interviewed or were supposed to be interviewed at least once.

The data set provides gross cross-sectional information over time for all SOEP individuals living in realized households. Unique identifiers are PID SYEAR (PERSNR SYEAR) indicating individual household members over time. The personal IDs PID (PERSNR) and the Case-ID CID, indicating the source household within each (sub-)sample SAMPLE1, are fixed, whereas the household ID HID may vary for individuals over time.

Additional demographic information like SEX, GEBURT_v1/v2 and PNAT_v1/v2 are included in the dataset – indicating the available information at the time of the interview. For time-consistent applications, it is recommended to use the demographics in [PPATH/L].
