The variable DESIGN contains the weights to reweight the sampled establishments so that they are representative of the population. The population of the survey are all establishments in the establishment file of the Federal Employment Agency as of June 30, 2021 with five or more employees subject to social insurance contributions. Establishments were drawn as a random sample, stratified along three dimensions: establishment size categories, East or West Germany, and industry. Larger establishments were oversampled resulting in variation in the design weights. The design weights do not account for the (possibly selective) decision to participate in the survey. Reweighting only the surveyed establishments using the design weights does not result in a representative sample. Edition: international
